**CONSTRUTORA TENDA S.A.** ("Company" or "Tenda"), in accordance with the provisions of § 4th of article 157 of Law No. 6,404, of December 15th, 1976, as amended and pursuant to CVM Resolution No. 44, of August 23, 2021, hereby informs that the Board of Directors has approved an important change in its team of directors.

According to the Material Fact published on October 4<sup>th</sup>, 2021, Mr. Renan Barbosa Sanches accepted a new professional challenge as COO (Chief Operating Officer) within the Company, therefore, as of today he will begin leading the operations and business areas of the company's on-site business model.
