## MATERIAL FACT Stock Buyback Program

**CONSTRUTORA TENDA S.A.** (the "<u>Company</u>"), pursuant to CVM Instruction No. 358, dated January 3, 2002, as amended, hereby informs its stockholders and the market in general that its Board of Directors has approved, on this date, a stock buyback program (the "<u>Program</u>"), as set forth in CVM Instruction No. 567, dated September 17, 2015, as amended, under the following terms:

- **Purpose**. The purpose of the Program is to acquire shares issued by the Company in order to maximize shareholder value by allowing a more efficient management of capital structure. Such shares may later be cancelled, transferred and/or used for purposes of exercising stock options granted by the Company under the Stock Option Plan, approved by the Extraordinary General Shareholders' Meeting held on August 11, 2014, as well as the Restricted Stock Option Plans approved by the Extraordinary Shareholders' Meeting held on August 09, 2018 and later amended at the Extraordinary Shareholders Meeting held on October 4, 2018 or any new restricted stock option plans or stock option plans that may be approved.
- <u>Amount of shares that may be acquired</u>. Up to 5.408.832 (five million, four hundred and eight thousand, eight hundred and thirty-two) common shares issued by the Company.
- Term. Up to twelve (12) months, starting on November 9, 2018 and ending on November 8, 2019.
- <u>Intermediary financial institutions</u>. The transactions shall be intermediated by BTG PACTUAL CTVM and XP INVESTIMENTOS CCTVM.
- Funds to be used.
